Minutes of the January 17, 2005 Monthly Membership Meeting

•The January 17, 2005 meeting opened promptly at 7:00 pm with 36 people signed in. After the Pledge of Allegiance, President Tom Killian introduced the 2004 Board Members. The Secretary's report was accepted as was the treasurer's report.

•Our CPO, Rich Hladik then reported there were only three auto thefts in the area, one of which the keys were inside. Officer Hladik | Lyn Dexter - Secretary advised there is a citywide problem with



people leaving their keys inside their cars. The SPPD recently recovered a car with stolen items inside, but that was on the NE side. There were also two thefts in the area, one at Play It Again, and the other at a storage facility. When asked about the sexual predator list that had been supplied at every meeting, Officer Hladik stated the department was regrouping and should be able to supply such information at future meetings.

•The first speakers were Karen and Tom Gargiulo from the National Income Tax and Accounting. The have been in the business for quite some time and have an office at 2952 66th Street North. They are both certified and feel they supply private and personal service for their clients. They advised they can represent you in front of the IRS and can file taxes electronically. Further, they offer other services such as CPA, payroll, planning as well as many others. They welcome the neighbors to take advantage of their services with weekend and nightly appointments available.

•Our next speaker was Karl Nurse, President of C.O.N.A. (Council Of Neighborhood Associations). Mr. Nurse stated that he wants CONA to take a proactive approach to issues rather than a reactive stance. Further, in an attempt to help the neighbors in St. Petersburg, CONA is going to hold a meeting on Wednesday to discuss what issues they should be addressing set an agenda then work towards resolving these issues after the priority is set. This meeting will be held at the Sunshine Center, which is located at 330 5th Street North from 7:00 pm until around 8:30 pm with refreshments. The results of this meeting will be announced in the newsletter to inform the neighborhoods and to allow interested parties to participate. Monitoring such issues will aid at election time so as to determine if the politicians are really concerned with neighborhood issues.

•Mr. Nurse advised the common issues that come up include Codes and the Police Department. He did advise that due to CONA's input, the Codes Department has undergone some changes and should be working more efficiently in the near future. Other issues will most likely involve Crime, Recycling, Nuisance Noise, Underground Utilities, as well as Zoning and Development.

•The next order of business was the 2005 board elections. The election committee consisted of Steve Plice, Ed Carlson and Mary Scott. This committee nominated the following candidates for the board: President, Tom Killian, Vice President, Ron Russell, Secretary, Lyn Dexter, Treasure, Linda Mouriski, Board Members; Skip Mitchell, Larry Dosh and Bob Miller. After this announcement, the committee offered to take nominations from the floor, however there were none. It was then moved by Ed Carlson, seconded, then a unanimous vote



•Tom Killian then advised of the status of various ongoing projects. He advised of a meeting with Lee Metzger with Leisure Services regarding the skateboard park. A flyer was passed around showing the design of the park, which differed from the first park built at Fossil Park. Further, the hold up of construction is the moving of the BMX facility, which will begin after a big event scheduled for May. If the BMX is moved out by the end of May, the new park should be ready by the end of the year.

- •Tom Killian then announced the scheduled events for 2005 including:
- •February 14th and 28th Neighborhood cleanup, check the newsletter for a map of the neighborhood and the dates of the pick up.

•February 26th Neighborhood Garage Sale, contact Brad Rice for a table. This will take place outside the Walter Fuller Center in conjunction with the youth center. \$10 per table for non-members and \$5 for JTCA Members. •March 26th Easter Egg Hunt, this year the Azalea Neighborhood will be co-sponsoring this event. The Easter Bunny will be available for photos with the kids.

•April 18th Monthly meeting will be held at Sunken Gardens. Mary Campbell will be speaking after which we will be allowed to walk through the gardens. Any one requiring special assistance with transportation should contact a board member.

- •April 23 and 24th Green Thumb Festival, JTCA will have a booth for which we will need volunteers to man.
- •October 8th Pets in the Park, this year we will add a Blessing of the Animals by Mary Beth Packard.
- •November 5th Neighborhood Picnic, this year will be held in conjunction with CONA and will be held at the Water Fuller. There will be food and Blue Grass Music.
- •Tom Killian then took a minute to thank all those who volunteered their help with the events last year and commented that additional volunteers are needed for the upcoming events. He also advised of the monuments that are to be placed in the industrial park, which will be funded through a Grant from the City.
- •Ron Russell then advised that if there were enough people interested, we could organize a trip to the Crime Lab facility. Please call a board member if interested.

•There were several questions from the attendees of the January meeting regarding the legality of scooters. Scooters (non-motorized) need to be registered and can only be on a private land. If ticketed, the fee is \$80 and the owner has to walk the scooter home if he/she gets a ticket. If motorized, a scooter must be licensed and must operate on the street, not on the sidewalk. However it is only required to have insurance if driver is not wearing a helmet.

•The meeting was adjourned at 8:31 pm

The principle use of Grandma's apron was to protect the dress underneath, but along with that, it served as a holder for removing hot pans from the oven; it was wonderful for drying children's tears, and on occasion was even used for cleaning out dirty ears.

From the chicken-coop the apron was used for carrying eggs, fussy chicks, and sometimes halfhatched eggs to be finished in the warming oven.



When company came those old aprons were ideal hiding places for shy kids; and when the

weather was cold, grandma wrapped it around her arms.

Those big old aprons wiped many a perspiring brow, bent over the hot wood stove. Chips and kindling-wood were brought into the kitchen in that apron.

From the garden it carried all sorts of vegetables. After the peas had been shelled it carried out the hulls.

In the fall it was used to bring in apples that had fallen from the trees.

When unexpected company drove up the road, it was surprising how much furniture that old apron could dust in a matter of seconds.

When dinner was ready, Grandma walked out on the porch and waved her apron, and the men knew it was time to come in from the fields for dinner.

It will be a long time before anyone invents something that will replace that old-time apron that served so many purposes.

Exterior Renovation Also Planned As Part Of Redevelopment -






Neighborhood Cleanup Days


Jungle Terrace Civic Association Boundry Map





Did you know one of the most stressful aspects of modern life is dealing with the problems that arise after an automobile accident?


