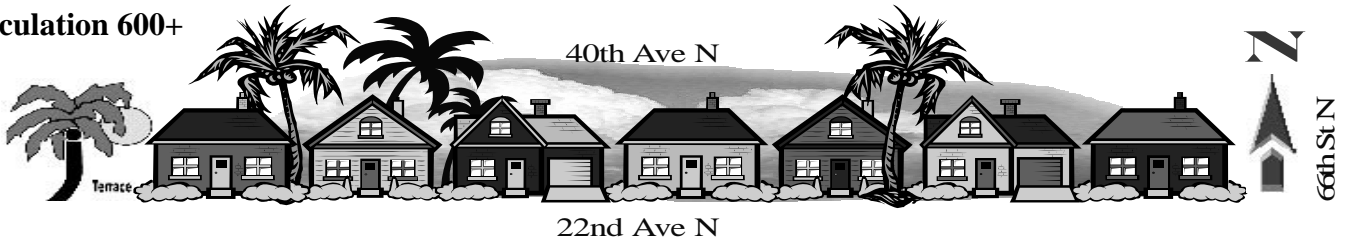

Minutes of January 15, 2007

- The Meeting started at 7:00 pm. 30 people in attendance
- Officer **Rob Arrison** spoke about the new policing policy. There are three districts in St. Petersburg and each district has 1 sergeant and 4 CPOs. To reach one of the CPOs for our district, please call 551-3183. Calls are returned within 24 hours. Questions were asked and answered of Officer Arrison.
- Our new councilman, **Herbert Polson**, introduced himself and discussed numerous issues, including the Pinellas Trail and Walter Fuller Park and the Devil Rays' spring training complex. He discussed the elections coming up on March 13 and that it was important to vote. One of the issues to be voted upon is the Penny for Pinellas tax and whether it should be continued. Questions were asked of Councilman Polson and were answered.
- **Steve Zachem** reported on the Porter Development project on 66th Street between 13th Avenue North and 18th Avenue North. The condos are out due to financing but a new Publix will be built at the site.
- **Tom Killian** spoke about the Neighborhood Cleanup days: February 5 for those living west of Tyrone Blvd and February 12 for those living east of Tyrone Blvd. He also discussed establishing

an Art Grant Committee for the site at 22nd Avenue N. and 29th Street N., across from Azalea Middle School. He also discussed ways to pay for that Grant, including having members sign up for one hour per week to monitor lighting or for house painting for those who are unable to paint their own home for whatever reason. A positive vote to pursue a partnership grant for art was taken.

- The Minutes of the November 2006 meeting were moved and seconded to accept as stated in the newsletter and passed unanimously.
- **Skip Mitchell** from the Nominating Committee discussed the nominees for the election: President, **Steve Zachem**; Vice President **Ron Russell**; Secretary **Paula Zachem**; Treasurer **Lynn Dexter**; Board Members **Skip Mitchell**, **Linda Mourski**, and **Linda Sessions**. It was moved and seconded to accept the nominees as stated and it was passed unanimously.
- **Steve Zachem** discussed proposed changes in the newsletter, including doing a bi-monthly newsletter and/or raising rates. If anyone would like to be the newsletter editor, please contact **Steve Zachem** or **Bob Miller**.
- It was moved and seconded to adjourn the meeting, which passed unanimously. The meeting was adjourned at 8:03 pm.

Hurricane Protection Garage Door Bracing

First the disclaimer. I am not a structural engineer. I'm providing this info as just another homeowner in the Jungle Terrace Neighborhood. My homeowners insurance has gone through the roof as I'm sure your's has. I spoke to my insurance company and there are several things you can do to receive a discount. If you have replaced all you windows with hurricane rated windows you can get a discount. I replaced all my windows except three. Woops, no discount for me. You can get a discount for approved window protection. I have plywood for my windows. Woops, plywood is not approved. Do you see a pattern here?

I decided to raise my hurricane deductible to 10% to lower the cost and then do what I can to "harden" my home to protect it during storms.

You may recall that I wrote an article about making and installing plywood covering for your windows. You can see that article on our web page at

A condensed version was in the August 2006 newsletter, also available on our web site.

I found some very good information about protection homes from storm damage at the **FLASH** "Federal Alliance For Safe Homes" web site. **Blueprint for Safety** can be viewed at <http://www.blueprintforsafety.org>. I discovered that a major weakness at many homes is the garage door. My garage door is a double wide (16') door and although I thought it was hurricane rated, it isn't. The giveaway is that only one brace spans the top panel of my door. When I tried to find a source for the manufactures hurricane bracing I discovered it would be easier to replace the door so I looked for another solution. I think I found one.

The first thing I did was put 16 foot 2x4's on each of four

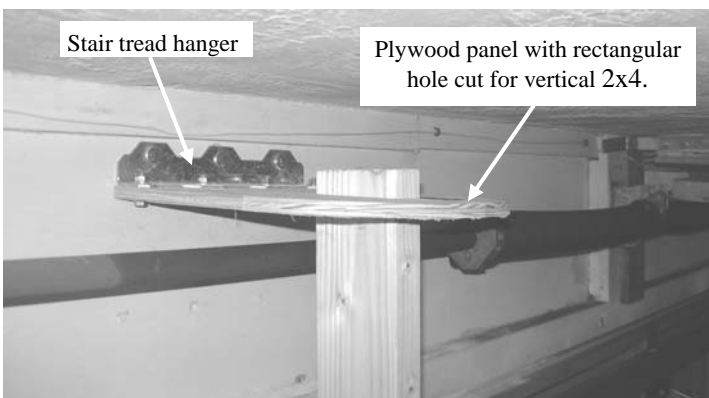
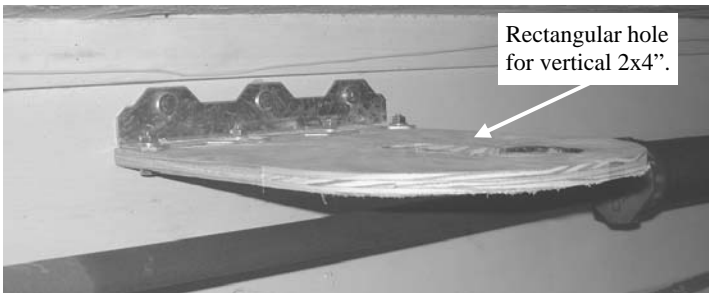

horizontal panels. The biggest problem here was getting them home. A rug on top of my truck and some twine to tie the ends to my bumpers solved that problem. I used clamps to hold the 2x4's on the door panels (pg 4) so I could drill holes and install the bolts. I used stainless 1/4" x 2 1/2 " bolts with nut and flat washers.

This braced the panels horizontally but I saw a need for vertical bracing also. I decided to use four 8 foot 2x4's for this. I went to one of our local home improvement stores and did some looking around (I love doing that) for some ideas. My solution had to be simple, easy and fast to install.

I found some stair tread hangers. They are normally used to attach to a wall or board etc. and provides a place to support stair tread. I attached them to the wall above my garage door and made wood panels to attach my vertical 2x4's to.



The rectangular hole was cut with a Jigsaw.

Position the stair tread hanger and board so they don't interfere with the garage door opening and closing.

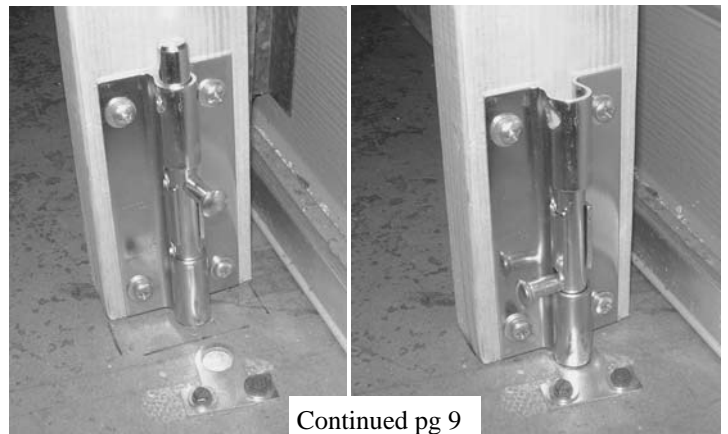

I decided that I needed four vertical 2x4's. When installed I used clamps to hold them to the horizontal 2x4's.



To keep things simple and fast I used heavy duty gate catches on the ends of the vertical 2x4's. You will need a hammer drill to make the hole in the garage floor for the gate catch pin.

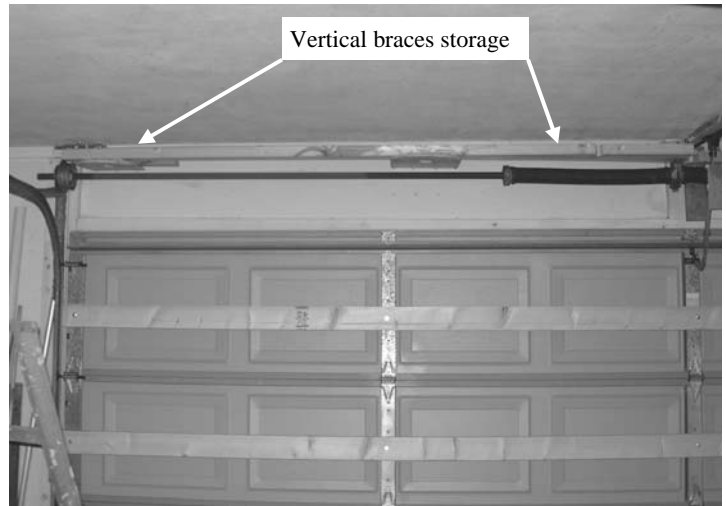

All together I have less then \$150 invested. OK it took some time to think it through and install it but I enjoyed that too. If you decide to do this don't forget to disable (unplug) your garage opener when the vertical braces are installed. 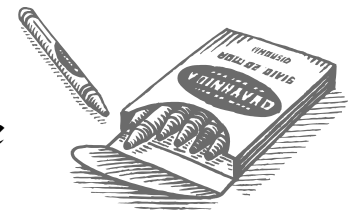

New! Water Restrictions

St. Petersburg is in a water caution area as defined by the Southwest Florida Water Management District (SWFWMD) and is committed to water conservation. Water restrictions have been placed on outdoor water use and will remain in effect as dictated by the SWFWMD and St. Petersburg. Please note that these restrictions are for St. Petersburg only. If you live outside the city limits, please check with your municipality, Pinellas County, or the SWFWMD for the current water restrictions in your area.

This declaration has required the City of St. Petersburg to restrict watering with potable (city) water, private well water, and private connections to surface water sources (lakes, ponds, etc.)

to once a week, according to the schedule below. These restrictions go into effect January 16, 2007 and end July 31, 2007. Restrictions for reclaimed water users is three times a week and voluntary.

Pinellas Trail by Dr Ed Carlson

Following our **Councilman Herb Polson's** initial effort to bring Pinellas Trail up to the quality of other parks in St. Petersburg, **Dr. Ed Carlson** surveyed the Trail for a unified approach to improvements. Our Neighborhood Plan lists 3 Parks -- and The Trail is one of them -- a Linear Park. The City may have to be the Contractor for the County on the portion of the Pinellas Trail in our City. Majority of the Trail is in our District 1. The rest is in **Rene Flowers'** District 7 -- a GREAT ally for getting things done!

Findings and suggestions:

Good Things.

1. Florida Progress recently removed huge trees under the power line running along trail -- some pine trees almost 2 feet across (a few logs in ditch), and palm trees around base of Power Poles. I have experience with Power Companies and various forms of vegetation control (costs them \$3 BILLION a year!)
2. The Trail Ranger IS trimming south of 22nd Avenue. Really good job behind PUBLIX (not clean our major trash from ditch) -- then seems to be tiring -- only lightly trim down to ditch, not in ditch or the huge Brazilian Pepper (B.P.) trees on the other side of ditch. NOT clean major trash from ditch. Has only a power polesaw and weed eater. Is NOT the Contract crew. No vegetation control/kill is utilized, and the cattails in the ditch will be 6 feet high in a month or two.
3. Access Openings exist at 76th Street at 35th Ave -- Both Sides. 34th Ave both sides. 32nd Ave on the residential side.

Improvement needed.

1. Walmart side, good up to fence, ditch on Tyrone side of fence is a total mess - filled in, overgrown B.P.s, Graffiti on back of yellow building west of Williams Sub complex.
2. 38th Avenue headed South, Texaco station needs to paint roof beams - eyesore from the 38th Ave Overpass. Ditch to left, on outside of fence, is a mess, filled in, overgrown with B.P.s and palms. Ditch is NON-functional to minimally functional -- bring to optimally functional. Major renovation of ditch the entire length of Trail. See Flood pictures provided. At 32nd Ave, ditch shifts to right of trail, no connector under trail -- separate ditch. Mowing -- remove concrete chunks and logs to simplify and beautify. Backs of some buildings are a mess -- Codes inspection. Trail Trees -- Trim to 8 feet high per City regs. REMOVE any not beneficial.
3. Tyrone Overpass -- looks pretty good. Trim trees to 8 feet from ground. Ditch on north side -- much trash. SAFETY Correct steel posts blocking cars from trail to 1 marked plastic like at 22nd Ave so Police can run over it if necessary. Trail is wide enough for Police and Emergency

Bald Eagles Call Science Center Home



A pair of bald eagles have set up housekeeping on the Science Center property located at 22nd Avenue North in St. Petersburg. The nesting pair was discovered a few weeks ago and seems to be settling in nicely.

According to the Audubon Center for Birds of Prey Training Manual, bald eagles build the largest nest of any bird in North America. They reuse their nests each year and increase the size. Nests can last for 20 years. There can be up to four eggs and they usually begin to hatch within 33 to 35 days. The manual adds that more than 7 thousand pairs of nesting bald eagles can be found in the contiguous United States.

Visitors are invited to view the nest at the Science Center from a distance on Fridays from 1-4 p.m. They will also be able to visit the 600 gallon marine touch tank, the animal room, the alligators, tour all exhibits at the Center and enjoy a 3 p.m. Planetary Show for just a \$5 admission.

The Science Center is a non-profit, private, hands-on science education facility funded by grants and contributions by corporations and individuals.

Vehicles. Educate Police on how to access Trail in cruisers. CONNECTOR to Tyrone Mall needed South of Over-Pass. CONNECTOR to JTCA Neighborhood needed South of Over Pass. Suggestions below. Red Cedar -- long stand on right. Trim 2-4 feet off the ground since upright branches. Al Jones maintenance at Walter Fuller Park and I can do that in a day -- when send city truck to mulch up or pick up trimmings.

4. 2nd Avenue: MEDIAN -- replace Pedestrian Protector Bollards -- majority are MISSING. South of 22nd Avenue -- lots of defective trail fence. DO WE WANT TO GO TO 6 foot high fencing -- rather than 3 feet high -- for SAFETY.

ACTIONS to take: for ENJOYMENT and SAFETY.

1. Police CEPTED Safety study and implement recommendations. Police taught cruiser-access to Pinellas Trail. Trail made accessible to police cruisers for emergency.
2. Urban Forester marks trees to be removed, and remove them. Good time for B.P. control. Use "stump killer" on all cut trees to prevent re-sprouting.
3. Mike Connors and PUBLIC WORKS to assess DRAINAGE, and schedule clean out of DITCH.
4. CODES inspection of backs of buildings entire length of trail. REQUIRE that Address of buildings be put near roof on every building on Trail side for reporting either location on trail, or needed improvements.
5. LOCATOR NUMBERS on Trail every quarter mile -- paint on trail Mile Marker 2.5, 2.75, and ARROWS showing "North to Tyrone", "South to 22nd Ave" etc so can call for HELP or REPORT location of issue for attention. Now is no way for average person to say where they are on trail.
6. Enlist (or Require) businesses to maintain once cleaned up -- just like street right-of-way. Determine Right of Way, Property, and Property Lines.
7. City takes over Maintenance Contract, paid by County (as City did for DOT Contract on I-275).
8. CONNECTORS

A. City Owned Property off Tyrone (30 something) can be small park and access from Tyrone Blvd.

B. Tyrone Square Mall can make nice connector(s), benches, bike racks, etc.

C. JTCA in order of best first. (Even if have to build a fence with top (tunnel) to connect.

(1) City owned right away if there is one.

(2) North of 2601 Anvil -- between buildings

(3) Anvil Curves onto 30th Avenue -- lots of space between buildings (outside edge of curve) to just south of Over Pass.

(4) 2501 Anvil, fenced parking lot, nothing in it. or lesser 2301 Fla. Progress substation.

(5) 72nd Street at 30th to frontage road along Over Pass. Now open, Private or Public? DOES 72nd Street still have a right of way, or been vacated?
