

### Minutes of the February 20, 2006 Monthly Membership Meeting

Provided by Paula Zachem

The meeting started at 7:02 pm.

The speaker was **K.C. Jones** of Realty Executives. She discussed the increase of home values over the past few years. She also discussed several ideas of how to increase a home's value. There are currently 44 homes on the market in our neighborhood.

The Minutes were approved as presented in the February 2006 newsletter.

**Yusuf Saeed**, gave the Treasurer's Report. He explained the balance and what some of the funds were for and that further research was needed to make sure our treasury was in order. Yusuf asked **Tom Killian** to explain the monuments in the neighborhood and the status of one last one to be built.

Officer **Scott King** of the St. Petersburg Police Department gave the crime report for our area. Then, he discussed that most of the crime in the area, other than at Tyrone Square Mall, were the type - residential burglaries, in a small concentrated area, most likely occurring when people are at work. Officer King also reported on the new Tasers in use by the Department.

**Steve Zachem** gave the report from the CONA meeting regarding the proposed project at Ninth Avenue and 66<sup>th</sup> Street North and that CONA voted against supporting that project. **Ed Carlson** also discussed this matter and that the City Council meeting regarding this project was the next evening and to come to the meeting to speak against this. **Steve Zachem** also reported on other notices the Association had received regarding other properties in the area, one of which was a notice to vacate an alleyway.

**Steve Zachem** also reported on upcoming legislation about a change to the Save Our Homes exemption for homeowners and certain members in the Florida legislature were proposing to extend it to commercial land as well. **Emily Coeyman** voiced the importance of registering with Sunstar in case they are needed to come out. She also mentioned an exemption for low-income seniors on top of the homestead exemption that currently exists for homeowners.

Approximately 41 years ago, a few men decided to form a baseball league for the neighborhood boys. They had not much money, but a lot of hope.

Shortly after the league was formed, the men were able to buy a stretch of land that extended from around 38 Ave. N. - 46 Ave N. - behind the present day Albertson's. They bought this land for \$6000.00 from Mrs. Grinier and paid it off in 1972. A few years later, the son of Mrs. Grinier, Fred, donated the rest of the land to the Cornerstone Church. The church allows NWLL to use part of their land for parking and some other activities.

There was an old home at the back of the lot. This home was converted into a concession stand. Through the years, it has been remodeled several times, but is still the original building.

The field is named for Hink Smith, one of the founding fathers, who was very faithful to the league until his death. He was always at the left field fence

watching over the games. The T-Ball Field was donated just a few years ago by Tom Turner, who had no children playing ball, but wanted to do a good thing for the neighborhood children. His help is much appreciated.

Most of the children playing at Northwest live in the Jungle Terrace Neighborhood. Through the years, we have enjoyed many great ball games and made many special friends.

## Questionable tax benefit:

A proposed amendment to Section 4 of Article VII of the State Constitution is currently working its way through various committees of the State House of Representatives and the State Senate. Senator Michael Fasano and Representative Frank Farkas are the amendment's sponsors.

At first glance, Senate Joint Resolution 22 / House Joint Resolution 33 appears to provide some tax relief to property owners. The plan is to take the protection of *Save Our Homes* a 3% cap on annual increase in a homes value—and extend that protection to commercial real estate. The trouble is that this will eventually cost homeowners more. Since counties are primarily funded through property taxes, decreasing income in one area



will create a shortage. If the counties are unable to bring in money from commercial developments-traditionally some of the highest valued real estate in any area—where are they going to make up the difference? The shortage will be compensated for by increasing the millage rates to all taxpayers.


New homeowners may be complaining about the iniquity of paying more taxes than long time owners now, but if this amendment passes it will be considerably worse.

To confuse the issue even further, there are currently 7 amendments to Save Our Homes under consideration: the most significant of these is the proposal to make the 3% cap portable. More information on this subject, as well as the bills, can be found on the JTCA

### This Months Gardening Tips Providedd by our Editor

Mango - Mango trees should be sprayed with copper fungicide as soon as the flower buds appear to control anthracnose. Continue spraying monthly until mid-May or mid-June; depends on the variety you are growing is early- or late-maturing.


Lawns - Fertilize two weeks after the grass resumes spring growth. A 16-4-8, 15-5-15 or several other fertilizer analyses can be used. Apply a preemergence herbicide for crabgrass. If verticutting (thatch removal), it usually should be delayed until the period between March and May to allow for better recovery from the process. Newly verticut lawn will require similar care as a newly installed lawn: an application of fertilizer and more frequent watering than an established lawn would need.

Azaleas - Should be pruned shortly after the end of the flowering. The time this occurs will vary with the cultivar and weather conditions but is often in March or April.

**Tomatoes** - Most vegetables need to be fertilized about every 3 weeks if a granular fertilizer is being used. A 4-6-8 (often packaged as a citrus fertilizer) is one of the fertilizers that can be used.

**Pruning trees** - Winter is also an excellent time to prune most kinds of shade trees. Use sharp tools of the proper size for the branches you want to remove: pruning shears for small branches and twigs, loppers for branches up to 1/2 inch in diameter and pruning saws for larger branches. There is no need to paint the pruning wounds.

**Aphids** - Watch the new growth on landscape plants for signs of aphids. If no ladybugs are seen on the plants it may be necessary to spray. Soaps and/or oil sprays are a low toxicity alternative to more potent insecticides.
