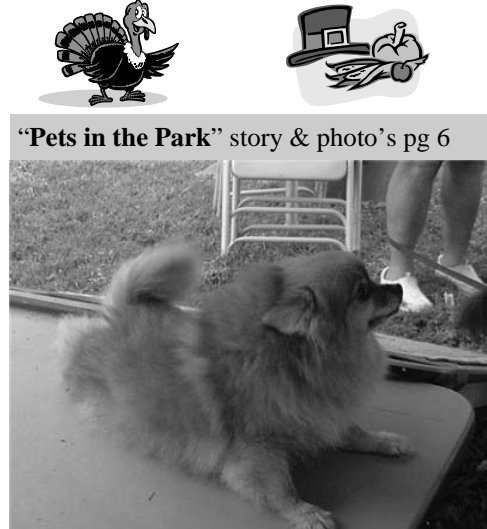

### Linda's Sausage Dressing

- 1 lb. sausage (i.e. Jimmy Dean)
- 2 medium onions - diced
- 3 stalks of celery - diced
- 3 eggs
- Salt and pepper to taste
- ¼ to ½ cup of milk
- 2½ to 3 loaves of bread



Separate sausage to small pieces. Stir together sausage, onions, celery, eggs, salt & pepper in LARGE bowl. Toast and cut bread in small pieces. Add small amount of toasted bread. Stir to moisten. Continue to add toast and mix well. Add ¼ to ½ cup of milk to moisten. Form small patties on baking pan. Bake at 350 deg for 30 to 45 minutes until sausage is cooked.

# What's happening in the Terrace?

It's November in the Terrace!

Cool nights, days in the 80's, there is no question we are enjoying a beautiful fall in the Terrace! (Writer Note: I am not going to say there are turkeys popping up everywhere, as I did about the pumpkins in the last newsletter, for fear of finding a turkey head above my coat in this column). I have to admit, I asked Bob to put the pumpkin head layover in the column just to see if you were paying attention. I must report that very few of you made any comments, so I must say "you gotta pay better attention"! Now get out there and find the key!

Instead of the material I was going to write about concerning recent events which occurred in the Terrace, this article comes from my experiences in life and career. As you may or not know, my profession calls for me to not only mediate disputes (often involving insurance claims) but also investigate the occurrence including the determination of the cause and origin of many different claims.

In September, I received a call from an insurance adjuster asking me to determine the cause & origin of a fire which occurred on the East side of St. Petersburg. This adjuster also requested, because she received this claim as a rush (as the insured was severely disabled), I respond as soon as possible to make sure the insured's special needs were addressed. Upon my arrival on the scene, I found a well maintained, single family dwelling, the garage door of which was currently located in the side yard. It quickly became obvious the fire started in the garage. While the

remainder of the home experienced minimal to moderate smoke damage, the largest part of the fire damage was contained within the garage, where it caused heavy damage to the electrical panel and wiring for the entire house. As was stated by the insured's, the ability to isolate and contain the fire within the garage was due to the efficiency of the St. Pete Fire Department, who I'm told, went out of their way to aid these people during and after the extinguishment.

I, at this time, had the pleasure of meeting Mr. and Mrs. Insured's. Mr. Insured, who uses a wheel chair for mobility, is the recipient of bi weekly dialysis treatments from a local lab. Mrs. Insured can only be described as a very responsible and dedicated care giver to her husband. Here is the part that I had real problems accepting. For the next seven days we (Mrs. Insured, the adjuster, and myself along with many other members of the handicapped community, including advise from a member of C.A.P.I. {Committee to Advocate for Persons with Impairments, of which I am an alternate member} were unable to locate suitable temporary (approximately 90 days) housing which afforded the special needs of Mr. Insured. The largest problem encountered was the lack of a roll-in (no tub) shower.

The problem was resolved by an exhaustive effort put forth by the contractor to restore the electric and the City of St. Petersburg who coordinated their expeditious inspections. Also noteworthy were the innovative efforts of Mrs. Insured when they (she

and her husband) reconciled themselves to occupy the home during the day (thus allowing Mr. Insured to take a cold shower {for at least 7 days due to lack of electricity} in his own home) then returning to a Motel at night. I am sure you will all be happy to know these folks are back in their home and while the repairs continue, they will be in their home for the forth coming holidays.

My decision to write this article came only after noting the displeasure of the sitting Council Member from this district following the October CONA meeting. The Council Member feels, as do I, there should be more facilities within the City, other than the few motels that are truly and properly handicap equipped rooms, capable of accommodating the special needs of our physically challenged neighbors. As I related to the committee at the last C.A.P.I. meeting, I do not know exactly what route to take to alleviate this problem. I am hoping one of you can provide some advice as to how and to whom I should direct this information.

On a personal basis, I wish to say I hold very high the many people in the JTCA as well as the many folks that took an active part in the pursuance of the Amber Plan including the many great people I had the pleasure of working with in not only the City of St. Petersburg, but also the great County of Pinellas, the Florida Department of Transportation, the State of Florida including Governor Bush by promoting the Plan in the bay area. You must remember, it is **YOU** who will make the difference!

By the time you read this, the election



will be history and we will be looking forward to a fantastic Holiday season as well as a New Year in which I hope we will all prosper and remain in good health. I look forward to working together in the year to come, as we have in the past, to make the changes needed to achieve the goals of our neighborhood, and our City, to make it a great place to live! To all of you I say have a Merry Christmas and a Happy New Year. Until 2004, "I'll be seeing you in the Terrace."

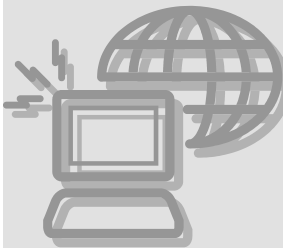
## Frugal Sports
