Newsletter Brief: NEW Reclaimed Water in Jungle Terrace

Jungle Terrace is eligible for "Seasonal Reclaimed Water" --

RCW may be restricted or not available March, April, May.

Requirements: Petition that 51% of residents in your neighborhood want the service. Water Department will then develop estimates of costs to extend service to your area. New RCW service must be paid for before projects are approved and initiated.

2010 Census Cautions

The Better Business Bureau (BBB) advises people to be cooperative, but cautious, so as not to become a victim of fraud or identity theft. Census workers have begun verifying the addresses of households across the country.

HOW do you tell the difference between a U.S. Census worker and a con artist?

** A Census worker will have a badge, a handheld device, a Census Bureau canvas bag, and a confidentiality notice. Ask to see their identification and their badge before answering their questions. Never invite anyone you don't know into your home. Talk through the door.

** Do not give your Social Security number, credit card or banking information to anyone, even if they claim they need it for the U.S. Census.

Census workers may contact you by telephone, mail, or in person at home, but NOT by Email. Be on the lookout for Email scams impersonating the Census. Never click on a link or open any attachments in an Email supposedly from the U.S. Census Bureau.

March of 2010, census forms will be delivered to every residence. Just answer the 10 short questions and then mail the form back in the postage-paid envelope provided. If you don't mail the form back, you may receive a visit from a census taker, who will ask you the questions from the form. For every address that doesn't mail back the form, a census taker must follow-up in person to obtain the responses.

The Census is Safe

The 2010 Census will ask for name, gender, age, race, ethnicity, relationship, and whether you own or rent your home - 10 simple questions that will take about 10 minutes to answer.

The Census Bureau safeguards all responses to the highest security standards available.

Your answers are protected by law and are not shared with anyone. The census taker who collects your information is sworn for life to protect your data under Federal Law Title 13. The penalty for unlawful disclosure is a fine of up to \$250,000 or imprisonment for up to 5 years, or both.

When Census Takers will be Going Door-to-Door

From April to July 2010, the Census Bureau will knock on the door of every household that does not mail back a completed 2010 Census form.

It's critical that you take just 10 minutes to fill out and mail back your form rather than wait for a census worker to show up on your doorstep. About \$85 million in taxpayer dollars are saved for every one percent increase in mail response.

The Census Bureau must get a census form to – and a completed form back from – every residence in the United States. That's more than 130 million addresses. This is why the census is the largest domestic mobilization our nation undertakes.

How to Identify a Census Taker

The census taker must present an ID badge that contains a Department of Commerce watermark and expiration date. The census taker may also be carrying a bag with a Census Bureau logo.

The census taker will provide you with supervisor contact information and/or the Local Census Office phone number for verification, if asked.

The census taker will ONLY ask you the questions that appear on the census form.

What the 2010 Census DOES NOT Ask

Census takers will not ask you for your social security number, bank account number, or credit card number.

Census takers never solicit for donations and will never contact you by e-mail.

In new business, it was mentioned that if anyone has plants in their yard they can donate for our Garden, mainly flowering year round plants, ferns, etc.


Upcoming meetings: March will be Councilman Polson. In May we will be holding our meeting at Sacred Lands.

News from the Jungle

We live in an historic section of St. Petersburg. The area west of Park Street, at one time, was the site of many Indian Burial mounds. Panfilo de Narvaez is believed to have landed at a site near the Jungle Prada in 1528. There was a Tocobaga Indian village there at that time. Shell mounds extended along the shore



where the Indians cracked open shells for food and left them in a pile.

The Jungle Prada shopping complex had several stores and a gas station. It also had a night club, the Gangplank, which was the first nightclub in the city. It is said that Babe Ruth was married there.

We had the Jungle Country Club at Park Street and 5th Avenue No. The original club house is now the Farragut Academy. It included a golf course that opened on January 1, 1916. Two holes of the golf course were located where 22nd Avenue North is now located. Did you ever wonder why so many streets in the Azalea area have names that relate to golf?

The Piper-Fuller Flying field was built around 1926 and was just west of the Mall. It was the first airfield in St. Petersburg and the third in the state. Albert Whitted and Grand Central airfields both followed in 1929.

If you would like to read more about the history of our area just go to our Jungle Terrace Civic Association web site and click on POINTS OF INTEREST. You will find information about Abercrombie Park, Jungle History, Jungle Prada, and Lighthouse Point, Piper fuller Airport, Sacred Lands, Science Center and Walter Fuller Park.

In an effort to reduce the ongoing operations and maintenance costs of the city owned facilities of the Naimoli and Al Lang complexes, the city executed an agreement with St. Petersburg Baseball Commission, to operate, and maintain the facilities. The management company is expected to provide affordable entertainment and use them as opportunities for baseball and other sports activities. The initial term of the agreement is for three years. The annual projected saving to the city is \$680,407 or \$2,041,221 over the full term.

What do you think?

The little used baseball training complex in Walter Fuller Park still has a sign calling it "Raymond A. Naimole Baseball Complex." Western St. Petersburg's Valuable Historic Site

Valuable to all of St Petersburg is one of its earliest historical sites located between Park Street North and Boca Ciega Bay across from Elbow Lane. Hundreds of vehicles pass by this area every day not noticing nor knowing the significance of the area. Some notice the informational signs but know little else about the importance of the area they have just passed. Unique multiple features of this site include the following:

The site of ancient Tocobago Indian habitats including a large temple mound and other mounds in adjacent areas. The area surrounding the present Jungle Prada, including the historic probable landing site on April 14, 1528 of the

Spanish explorer, Panfilo de Narvaez.

The Jungle Prada (formerly Prado), one of Florida's earliest shopping centers and home to the infamous Gangplank restaurant. These were among the creations of pioneer developer Walter P. Fuller who also built the nearby Jungle Country Club (now Admiral Farragut Academy) all of which were built in the 1920's. Streets adjacent to historic brick-paved Park Street still carry the names of golfing terms as they wound through the former Golf Club.

This area was also the terminus of the Jungle Trolley that carried passengers from downtown St. Petersburg through the undeveloped wooded areas and north on Park Street.

Within a short radius of the Jungle Prada are numerous mansions, and many historic homes influenced by Span-

ish architectural design features.

Just as St. Petersburg has a wonderful historical museum located in eastern St. Petersburg on Tampa Bay, it seems perfectly logical to also use this invaluable historic site to house a museum in western St. Petersburg on Boca Ciega Bay. Some of the rationale for this proposal are as follow:

The Jungle Prada building itself is historic and could be saved from destruction and converted into a fascinating museum. The current apartments could serve multiple purposes including office space, housing historic artifacts and other collections. Possibly the western end of the building adjacent to the patio with the unique simulated ship's prows, could be used as a revenue generating snack area for the convenience of visitors to the area.

Much of the surrounding area is already property of St. Petersburg including the street, parking spaces for automobiles and boats, boat launching ramps, a pier situated on Boca Ciega Bay with a view of the inland water-

way and a small park and picnic area.

The large Indian mound is a recognized archaeological site and the location of archeological digs and research and many educational events, including the "Sacred Lands", so generously sponsored by the property owners, Eric and Doris Anderson, known for their intense interest

in preservation of the historic area.

Preserving this area for the edification of the public has many intrinsic values including field trips for students in public schools, private schools and academies, and historic studies for nearby St. Petersburg College and University of South Florida students.

From a less altruistic point of view and with the appropriate publicity, this fascinating complex could become a tourist attraction; also a boost to the local economy. Consider what areas such as St. Augustine have done to promote their historic roots. Just how many nonnatives of this area (as well as our own residents) know nothing about the fascinating history in our very midst in western St. Petersburg?

The purpose for putting these ideas in writing is because when talking with many people over recent years (including our mayor, several council persons, historic preservationists, museum personnel, neighborhood associations, professors and other friends), I have always received positive feed-back and encouraging support for these ideas involving this valuable historic area. Unfortunately it has been so under valued in spite of being situated in the very midst of one of this areas most attractive locations.

It would break my heart as well as challenge my respect for local history to someday pass by the Jungle Prada area only to witness the wreckage of this irreplaceable local landmark. Please, let us support each other and work together to preserve this unique area.


