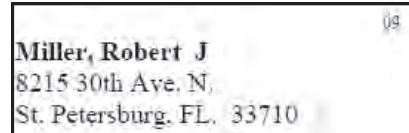

## Safety in Jungle Terrace

Robbery of Park Street 7-11; Shots fired at Tyrone Mall; Car-jacking; Woman stabbed to death; Boy molested on Pinellas Trail at 2pm . . . A discussion of safety in Jungle Terrace was initially picked up by the newspaper as "Everyone own a gun." See the Neighborhood Times article by Cristina Silva.

JTCA's March 16 program is Major Norm Belson, U.S. ARMY (Retired), Florida Certified Police Officer (Retired), 22 years civilian and military Police experience, military and civilian SWAT instructor, 10 years Vice and Street Crimes undercover officer, U.S. Army Counter Terrorist Planner, Special Operations Planner, NRA Trained Instructor. His wife of 40 years, Jane, is assistant firearms instructor. They have four children and three grandchildren.

Norm write, "I don't believe firearms training is the only step necessary to protect citizens. I take a very broad approach that includes robbery and burglary prevention, home defense and situational awareness. I offer a program, "Stay Safe Streets", as a community service to groups such as JTCA at no cost." Major Belson can tailor a security and defense plan for our neighborhood, or each participant. [www.StaySafeStreets.com](http://www.StaySafeStreets.com). Maj. Belson will provide updates on Concealed Weapons Permits, recently expanded laws, and the 33 states with reciprocity.

Pam and Becky suggested neighborhood training at Knights Shooting Gallery. Several neighbors responded eagerly. **March 29<sup>th</sup> at 2pm, Knights Shooting Gallery**, Is for JTCA residents. (12000 US Highway 19 N., 727-546-4447) Introduction for beginners and non-gun-owners: \$30 to shoot a variety of guns, or simply bring your own for target practice \$20.

A "Neighborhood Emergencies Plan" concept grew from the discussions:

- Guns are a method of defense, but not the only method. Tasers, umbrellas, situational awareness, placement of landscaping, and many more are all methods of defense.

- Preparedness for Fire, Hurricanes, Criminals, Riots, Floods and other untold events lies FIRST with the individual. Government agencies respond AFTER an event.

- We should plan for the worst and hope for the best - including training for defense.

Neighbor Helping Neighbor: This is training for defense – yes, it can include weapons of defense, though not to the exclusion of all other considerations.

Wild West 49ers circled wagons every night and practiced methods of defense. Had they had waited to circle wagons for the first time while fighting off the enemy and figuring out what to use for defense at the same time – America might still be East of the Mississippi. When Davy Crockett was out "huntin' bar," he did not leave his wife and children defenseless and weaponless at school or working the homestead.

A Times reporter asked Dr. Ed Carlson how he learned to shoot. "At age 11, I got on the S/P City bus with my .22 rifle and rode out to the Police Shooting Range. A lot of shooting badges were won at summer camp."

Several municipalities REQUIRE gun ownership. "March 1982, 25 years ago, Kennesaw (Georgia, suburb of Atlanta) unanimously passed an ordinance requiring each head of household to own a gun. Since then, despite dire predictions of "Wild West" showdowns and increased violence and accidents, **not a single resident has been involved in a fatal shooting** – as a victim, attacker or defender."

"Crime rates plummeted for several years after the passage of the ordinance. The 2005 per capita crime rate was significantly **lower** than in 1981, when the population of 5,242 had a crime rate significantly higher than the national average. Meanwhile, the population has skyrocketed to 28,189." [http://www.worldnetdaily.com/news/article.asp?ARTICLE\\_ID=55288](http://www.worldnetdaily.com/news/article.asp?ARTICLE_ID=55288)

"The key is to be prepared and not live in fear," Dr. Carlson said. (S/P Times 9/8/07)



## CONA 2009 Goals Report

This was my first invitation to the CONA Goals workshop. The objective was to create a list of the top 3 priorities for the organization for the next 18 months. I was asked to attend by Dr. Carlson. Although there were a few procedural debates, one of which I started, the process flowed pretty smoothly. Trust a West side neighborhood to stir things up!



The meeting began with an overview of the current CONA initiatives: Land Development & Historic Preservation, Public Safety, Court Watch, Energy & Environment, Leadership and Membership. We then moved into 6 groups to discuss the issues we thought were a priority, with a goal of 3 topics to present to the entire session.

All of the presentations were in the form of 3 items, with sub-headings under each item for specific emphasis. Every group listed Public Safety and Policing as a concern – including the Request for Proposal for the Sheriff taking over for St. Petersburg Police, the Matrix report, Clarification of the current Police statistics and staffing, and the current non-pursuit policy.

Development and Codes drew a lot of interest, but not as much passion as the previous topic. We discussed responsible development and environmental issues related to our previous years of accelerated building, including: water



use and run-off, pollution, decrease of permeable surface and aquifer damage, traffic issues, commercial and residential vacancy.

The vacancy issues surfaced concerns about squatters moving into these buildings. This is such an issue in Miami-Dade County, that some advocates are even working to match the homeless with vacant homes. Additionally quality of life issues and the perception of CONA within county government were discussed.

Although we could find no specific solutions—this was, after all, a goals session—I am confident that there will be something in the end product related to at least the policing and environmental issues.



Hopefully current funding realities will not prevent us from keeping this a great city in which to live. Barbara Heck has preliminarily defined the top 3 goals as:

- **CONA - Outreach and effectiveness**
- **Public Safety**
- **City Planning**

The specific points many of us emphasized will hopefully be implemented as the “how” to obtain these goals. I am pleased to have worked with such an able and wise group of citizens to discuss our concerns and how to address them.



## Coyotes in Pinellas

In the desert southwest it is common to hear a pack of coyotes baying in the evening. Not so in southern Pinellas county. It appears, however, that coyotes are here, making themselves at home in the mangroves and park areas.

This is not such good news for pet owners. While you may think your pet is safe from undomesticated wild life there are still some steps that can be taken to insure their safety.

Coyotes began an eastward migration, first appearing in northwest Florida in 1970. They are now found throughout the state. They eat just about anything, as long as it's an easy catch. This does include smaller domestic animals (but seldom people).

To make your home safe from coyotes, the "Desert USA" website offers a good bit of informa-



tion. ([www.desertusa.com/june96/cycot\\_qa.html](http://www.desertusa.com/june96/cycot_qa.html)) A few tips from this site include:

- Keep small pets inside from dusk until dawn. So far 8 pets have been documented as either missing or killed. If you know of any pets that are missing or that are known to have been attacked by a coyote, please contact Cathy Belcher at [4cathyb@gmail.com](mailto:4cathyb@gmail.com) to assist in her efforts to have the coyotes removed from the area.
- Install a fence; a tall privacy fence with a deterrent to keep the animals from digging under is best.
- Don't leave pet food outside, do not allow fruits to litter the ground.
- Secure your trash.

As our neighborhoods age, undomesticated wild life are regaining their territories. Even though the coyotes are not native, it seems as though they are here to stay. Take a moment to consider if your yard can be considered habitat!

## Demand Response Transportation (DART)

The Pinellas Suncoast Authority (PSTA) offers a special service for people with disabilities. It is offered to citizens of Pinellas County who are disabled or cannot independently use a regularly assessable bus. Care Ride currently has the contract with the County. They are a friendly, dependable company who have many vans which transport people to doctors, dentists, food shopping and other necessary appointments. My aunt and I used the DART services after her leg amputation. We were very pleased with them. They allowed me to ride free because I was the Caregiver. The current cost one way is \$3.50 or \$7.00 round trip. These are very reasonable prices compared to a private rental which would cost at least \$50.00 one way for a short trip. They also have taxi cab service available. You must apply to see if you qualify for their services, it takes about 21 days. Theresa Jackson 540-1849 is the person to contact. or you can download an application at [psta.net](http://psta.net) You may have to have your doctor sign paperwork regarding your condition. Please take advantage of this great program.

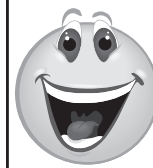

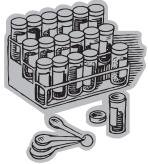
