## SPECIAL PRESENTATION - How to Survive a Fire in Your Home

This program will be presented by Capt. Ron Russell (vice president of JTCA). As many of you know Mr. Russell has been in the fire and law enforcement service for many years in Chicago. Mr. Russell founded his own company in 1974. This company first in Chicago opened up its first Florida office in 1982. Mr. Russell has been in the field of fire and explosion investigation for over 37 years.

During his career he has been called upon to teach fire investigation, as well as forensic pathology of the determination of cause and origin of fires and explosions to many private as well as governmental groups. Some of the group he has instructed are the FBI, ATF, IDLE. He has also taught shipboard fire-fighting as well as fire investigation at the US Naval Training Center in Great Lakes, Illinois. Amongst

many other courses taught he was requested by the combined Counties of Hawaii Fire Department to assist in the assembly of their arson investigative unit throughout the islands. Mr. Russell has also taught many seminars to the insurance industry as well as other law enforcement entities regarding fire characteristics and investigation.

It is the purpose in this presentation to anoint all of our neighbors how to survive, and assist your family in case of a fire in your home. Due to the importance of this presentation and the possibility of saving lives it is our suggestion you invite any and all of your neighbors and friends (members or not) to sit in on this presentation. 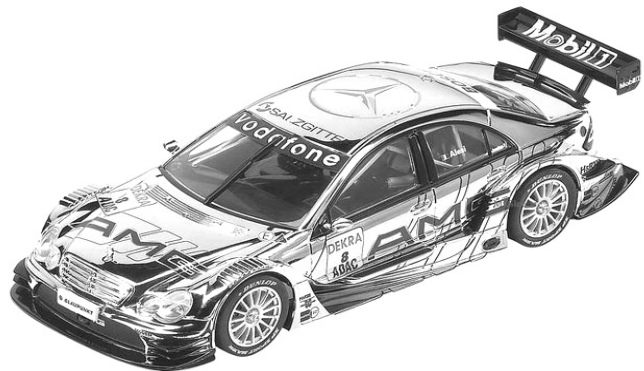

## Skateboard Facility ~ Neighborhood Decision ~ Motion

Our Neighborhood Plan incorporating our Written Park Master "Plan" (City Council approved in 2003) provides JTCA and RE-POP (The Real Environmental Preserve Our Parks, Inc.) the power to agree to changes in Walter Fuller Park in place of the City getting 65% of property owners within 200 yards of the Park to agree. This is a serious responsibility.

The "Plan" also provides B.3. "There shall be no more loss of open space in Walter Fuller Park." and C.1. "open space... means all land in Walter Fuller Park that is not covered by impervious surface."

Since BMX is not moving, the City is asking to construct a 22,000 sq. ft. Skateboard Facility east of the Community Center next to the outdoor basketball court – this is loss of open space.

2004, February 17, Tom Killian, JTCA President; Steve Plice, CONA Representative, and Dr. Ed Carlson, REPOP President met with John Green, Capital Improvements Projects Director, to provide written refinements to the Capital Improvements Project in Walter Fuller Park to be funded in 2007 and completed in 2008. This was followed by a letter of confirmation from the neighborhood leaders, on May 3, 2004.

The City has yet to confirm verbally or in writing. We must require these details in writing in "exchange" for our approval of the Skateboard Facility. REPOP is willing to agree to this exchange and approval.

We also need to SEE the revised parking plan and driveways for Walter Fuller Center.

### Neighborhood Requirements in exchange for approval of Skateboard Facility.

1. Driveways/curb cuts into the Park on the north side of 80<sup>th</sup> St. driveway entrance to Devil Rays, and Steel Barricades to prevent their use, are removed because they are "loss of open space" violating the "Park Plan."

For the weekend Green Thumb Festival, and 2 weeks Spring Training parking, a board ramp can be utilized, then removed. Additionally, the City agrees to continue to AEREATE the entire grass area utilized for car parking and Green Thumb exhibitors.

2. Decorative Lighting is completed around the Park and matched in the parking areas of Pool and Center – This includes 75<sup>th</sup> St along Azalea Little League. (30<sup>th</sup> Ave. along Azalea LL is already complete) – per the Written Park Plan.

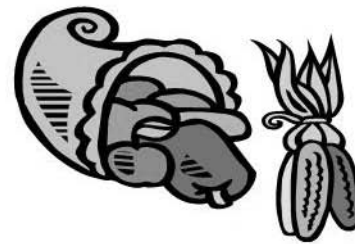

## Protect Yourself and Your Family Today!

In the event of a fire, properly installed and maintained smoke alarms will provide an early warning alarm to your household. This alarm could save your own life and those of your loved ones by providing the chance to escape.

### Why Should My Home Have Smoke Alarms?

In the event of a fire, a smoke alarm can save your life and those of your loved ones. They are a very important means of preventing house and apartment fire fatalities by providing an early warning signal -- so you and your family can escape. Smoke alarms are one of the best safety devices you can buy and install to protect yourself, your family, and your home.

### What Types of Smoke Alarms Are Available?

There are many different brands of smoke alarms available on the market but they fall under two basic types: ionization and photoelectric.

**Ionization alarms** sound more quickly when a flaming, fast moving fire occurs. **Photoelectric alarms** are quicker at sensing smoldering, smoky fires. There are also combination smoke alarms that combine ionization and photoelectric into one unit, called **dual sensor smoke alarms**.

Because both ionization and photoelectric smoke alarms are better at detecting distinctly different yet potentially fatal fires, and because homeowners cannot predict what type of fire might start in a home, the USFA recommends the installation of both ionization and photoelectric or dual sensor smoke alarms.

In addition to the basic types of alarms, there are alarms made to meet the needs of people with hearing disabilities. These alarms may use strobe lights that flash and/or vibrate to assist in alerting those who are unable to hear standard smoke alarms when they sound.

### Okay, Where Do I Put Them?

Install smoke alarms on every level of your home, including the basement. Many fatal fires begin late at night or in the early morning. For extra safety, install smoke alarms both inside and outside sleeping areas. Since smoke and many deadly gases rise, installing your smoke alarms at the proper level will provide you with the earliest warning possible. Always follow the manufacturer's installation instructions.

### Where Would I Get Smoke Alarms?

Many hardware, home supply, or general merchandise stores carry smoke alarms. If you are unsure where to buy one in your community, call your local fire department (on a nonemergency telephone number) and they will provide you with some suggestions. Some fire departments offer smoke alarms for little or no cost.

### Helpful Tip for Smoke Alarms

- Pick a holiday or your birthday and replace the batteries each year on that day.
- If your smoke alarm starts making a "chirping" noise, replace the batteries and reset it.

#### Are Smoke Alarms Hard to Install?

If your smoke alarms are hard wired, that is wired into the electrical system, you will need to have a qualified electrician do the initial installation or install replacements. For battery powered smoke alarms, all you will need for installation is a screw driver. Some brands are self adhesive and will easily stick to the wall or ceiling where they are placed. For all smoke alarm installations, be sure you follow the manufacturer's instructions because there are differences between the various brands. If you are uncomfortable standing on a ladder, ask a relative or friend for help. Some fire departments will install a smoke alarm in your home for you. Call your local fire department (on a non-emergency telephone number) if you have problems installing a smoke alarm.

#### How Do I Keep My Smoke Alarm Working?

- If you have a smoke alarm with batteries:
1. Smoke Alarms powered by long-lasting batteries are designed to replace the entire unit according to manufacturer's instructions.
  2. In standard type battery powered smoke alarms, the batteries need to be replaced at least once per year and the whole unit should be replaced every 8-10 years.
  3. In hard-wired, battery back up smoke alarms, the batteries need to be checked monthly, and replaced at least once per year. The entire unit should be replaced every 8-10 years.

**What if the Alarm Goes Off While I'm Cooking?**

Then it's doing its job. Do not disable your smoke alarm if it alarms due to cooking or other non-fire causes. You may not remember to put the batteries back in the alarm after cooking. Instead clear the air by waving a towel near the alarm, leaving the batteries in place. The alarm may need to be moved to a new location. Some of the newer models have a "hush" button that silences nuisance alarms.

**How Long will my Smoke Alarm Last?**

Most alarms installed today have a life span of about 8-10 years. After this time, the entire unit should be replaced. It is a good idea to write the date of purchase with a marker on the inside of your alarm so you will know when to replace it. Some of the newer alarms already have the purchase date written inside. In any event, always follow the manufacturer's instructions for replacement.

**Anything Else I Should Know?**

Some smoke alarms are considered to be "hard-wired." This means they are connected to the household electrical system and may or may not have battery backup. It's important to test every smoke alarm monthly and replace the batteries with new ones at least once a year.
