Pinellas Trail Safety Locators

November 2009, twenty-two West St. Pete Leaders, including two Council Members and six Police Officers met in the home of **Dr. Ed Carlson** to develop Pinellas Trail Safety and Maintenance. Yellow TRAIL PATROL t-shirts were created and distributed to over 100 individuals who volunteered to wear them on the Trail.



A major safety goal was Locator Markings for the Trail in St. Pete. **Councilman Herb Polson** took the lead stimulus for this project and the County took it on for the ENTIRE TRAIL!

July 2010 JTCA meeting, **Councilman Polson** demonstrated the NEW Pinellas Trail Markers. Each marker has a unique address, e.g. PT-0922, that is in the GPS locator systems for Police/EMS/Fire. Each Marker has the 911 number AND a number to report Maintenance/Graffiti issues! Markers are placed every 200 feet.

PT stands for Pinellas Trail. The City will follow through with marking all City Trails such as Skyway Trail may be "ST-0124".

This is a Giant Leap in SAFETY and APPEARANCE initiated by YOUR West Neighborhoods United, Inc. leaders, lead by JTCA. Thank you, **Herb Polson** for your focused leadership in accomplishing this forever benefit.

Mrs. Clara June Gibson

June 22, 1942 - June 30, 2010

I first met Clara Gibson when we were both enrolled in the Council of Neighborhood Associations of South Pinellas (CONA) Leadership Program. Over the course of the fivemonth session we became friends.

As a former proofreader for the St. Petersburg Times, Clara was definitely a stickler for details and made sure she crossed every "t" and dotted every "i" in any project she worked on.

As Secretary for the Jungle Terrace Civic Organization she kept detailed minutes of each meeting.

She also served on the Jungle Terrace Newsletter mailing committee. This is variable group of good people that meet at Tom Killian's house every two months, on a Saturday morning, to insert ad fliers into the JT Newsletter, fold and tape it, and put the mailing labels on.

I often volunteered for this committee, which offers plenty of time for camaraderie, conversation and laughs, and Clara always made me laugh.

Ever intrigued by her interesting earrings, I learned each pair had a story about her travels to China and Mexico, among other places, and the many friends she made on her travels.

Even as Clara fought her battle with cancer, she continued to make me laugh with her funny e-mails. Up to a week before she passed, I received lighthearted messages and would never have guessed that soon those funny e-mails and the unique person that was Clara would be gone from this world. Clara died on June 30, 2010.

Chaplin Theresa Peterson delivered Clara's up lifting

eulogy, held at the Memorial Park Funeral Chapel, on July 10, 2010, to an overflow crowd of her friends and family

Chaplain Peterson talked about "Clara's particular story" and how story matters. She related a warm and loving portrait of Clara's life from beginning to end.

Born on her grandparent's kitchen table on June 22, 1942 in Masury, Ohio, Clara lost her dad in a

traumatic accident at age eight. It was a loss that effected her deeply for years to come.

As a young woman, she set out for New York City to become an airline stewardess. She did join Trans World Airlines (TWA), but as a Teletype operator, and later she worked for several major financial firms and finally, she was a proofreader for the St. Petersburg Times until her retirement. She was an avid bowler, a member of First Unity Church and frequent visitor, with her beloved dog, Tilly at Walter Fuller Dog Park or Abercrombie Park.

Clara's sons and family had gathered a wonderful collection of photos from her life for the memorial service and it must be said, she was "a looker" and had a fabulous smile.

Chaplin Peterson compared Clara's life, and life in general, to a Nautilus shell. The Nautilus shell, lined with mother-of-pearl, grows into increasingly larger chambers throughout its life and has become a symbol for the stages of life, expansion and renewal.

The Jungle Terrace community surely misses Clara and the JCTA made a contribution in her memory to the Walter Fuller Youth Program to help keep her generous spirit alive through the young people that benefit from this wonderful program.



We appreciate the **City** continuing to plant trees in Walter

Fuller Park. In addition to the **37** on the East Soccer Fields and prior BMX around deepwater injection site, another **43** trees were planted around the lake. This brings our **New Tree Total to 80 trees!! Walter Fuller Park** is the **Crown Jewel** of City parks!

Dave Reed, in charge of lighting our city is greatly appreciated for integrating efforts with Parks to replace park lights that were out. **Stan Silverstein** marked these with red or orange ties. And, Park Maintenance Crew of **Wesley and Patrick** are keeping the park well manicured – a huge job for a huge park. Thank them personally when you see them.

JTCA does an annual CleanUP, weeds, reports maintenance issues, notifies of lights out, maintains the Volunteers Garden and plants flowers in Walter Fuller Park, and CleanUP in Abercrombie. Tom Killian and Ed Carlson participated in the Tampa Bay Estuary Program to learn about their grant applications.

At the request of Marianne Doane, Parks Services, Tom Killian, Ed Carlson, and Rich Meredith generated 4 letters from 3 neighborhood organizations supporting the City application for a Grant to improve Boat Ramps.

Codes: Azalea Little League property. The illegally constructed concrete drive way and parking pad was given a 2nd extension for 90 days. Their plan is to demolish and remove the entire structure. This was a major stormwater management violation that contributes to the flooding in the area.

FINALLY! After 10 months of research and sleuthing on the **parking lot** behind **Jared's Jewel-**

ers has all the trucks gone, is fenced and is For Sale by the bankruptcy Trustee. Jungle Terrace's **Tom Killian** and **Dr. Ed Carlson** led the process with help from St. Pete Police, Codes, Public Service Rep **Susan Fuchs**, Real Estate Broker, and bankruptcy attorney from Dallas, TX. Whew!

UPDATE: Jungle Lake outfall drain to Boca Ciega Bay:, from Carlos Frey: City Council approved the contractor, All American Concrete. There is a lead time on the fabrication of some structures. Construction is anticipated to begin early September, starting at the Boca Ceiga Bay outfall and working up 27th Avenue N to Walter Fuller Park. I'll share the schedule with you after we have our preconstruction meeting. As the project gets ready to begin, notifications will be made to residents along the route. Construction will begin at that point and last about a year.

First 25 Jungle Terrace Homes Are Sold; 175 More Are Planned

gle Terrace Homes has been sold, according to announcement by Walter P. Fuller, president of Jungle Terrace Sales Inc.

The entire project calls for 200 homes by the end of 1948. Ground was broken for the first unit the last week in August, and construction is being rushed by several crews using a production line technique.

AT PRESENT six houses have reached the interior trim state, while others are just starting up from the foundations.

Sales, however, have far out-stripped construction, according to Fuller, who with Harold S. Lake, Redington Beach, has the sales contract, Local brokers have been invited to participate.

Jungle Terrace Homes sell under \$10,000 and are financed with down payments as low as \$1,450 and monthly payments from \$38 to \$45.

Houses are concrete with varying floor plans. Variety and a pleasing irregularity it obtained by setting corner houses at an angle to both streets and by a wide range of treatment of porches, breezeways and garages. Steel window and door frames, steel sash and tile sills are some of the features. The use of a lot and a half gives plenty of play and garden space.

THE HOUSES are being built

First unit of 25 houses in Jun- at the north end of Jungle Terrace, centering at Thirty-eighth avenue north and Park street. The site is sufficiently removed from cross roads and highways for quiet and safety but near enough for direct access to St. Petersburg, the beaches and upcounty.

> Almost without exception Jungle Terrace Homes have been purchased by young St. Petersburg business people with families, Fuller says.

Builders and owners of the development are Karnes and Karnes, operating as Jungle Terrace Homes Inc. They have been active in local and Tampa building for a decade. The building is under sponsorship and ap-proval of FHA, permanent fi-nancing by Investors Syndicate of Minneapolis. Lake is local representative for the financing company.

Jungle Terrace History

This article appeared in the St. Petersburg Times in October 1947. It was provided by our neighbors Bill and Jane Emerson. The Jungle Terrace Civic Association was formed just seven years later in 1954.

A Challenging Win for JTCA

September 2009 JTCA began addressing the Commercial Trucks parking behind Jared's Jewelers. First we discovered this is not in any neighborhood association. JTCA took the lead going to Jared's, very cooperative, but leased the store. We located the property owner, very cooperative, but does not own the parking lot. Tax Assessor provided address of S&A properties. Tracked Mail returned. Internet search of Florida and ntional records show Steak & Ale dissolve in Chapter 7 bankruptcy in July 2008. Tracked mail sent to both Registered Agents and the prior CEO. Bankruptcy attorney call from Dallas, TX. Did not know they owned the property. Cooperative. 9 months later is For Sale, trucks gone, and property fenced. Whew!

Brings City Departments to the Citizens of the West Side

at the J. W. Cates Center

Living on the west side, it's about a seven-mile trip to City Hall, the Municipal Building or the Police Department. If you are able to get there during business hours and find parking, you would have to do a bit of



walking to get to the different departments and even then you may not get the answers you seek.

Now Mayor Bill Foster is offering citizens all over St. Petersburg the opportunity to come out to a community center near them or at any of the Mayor's Night Out locations and meet with the personnel from key City Departments.

You have an opportunity to sit face to face with someone from traffic management, neighborhood partnership, public service, codes, the police, library and parks and recreation.

At the July 27 meeting in west St. Petersburg at the J.W. Cates Center, Police Chief Harmon gave an overview of what these sessions are designed to accomplish.

- Report on questions or issues that had 1. arisen at the last meeting.
- 2. Allow time for break out sessions so residents can move from table to table, city department to city department and speak face to face with someone from the city about any particular concern.
- 3. After the break out, the group comes back together again for a wrap up and talk about the issues that were brought up. If they can be answered that night they are. If not, a promise is made to find the answer in a timely fashion and get back to an individual or the group.

I was able to talk to Officer Mitch Detty and ask questions about issues that had shown up in my CrimeReports.com e-mail near where I live and find out in more detail what had happened.

The next morning, my CrimeReports.com showed Proactive Policing had taken place that night in the areas I had asked about.

Next, I was able to sit and have a great talk with Neighborhood Traffic Manager Mike Frederick and find out what was going on along Park Street North.

District One Council Member Herb Polson was there too and available to talk and he appeared pretty busy.

Personally, I found out more and got more action on issues of concern at this event, than with email and phone calls.

Even in this age of technology, nothing beats a good face-to-face meeting.

Watering Restrictions

Twice a week watering restrictions are in effect

Applicable Areas

Please note, the following restrictions on outdoor water use are for St. Petersburg water customers located within city limits only. If you live outside city limits or receive your water bill from another entity, please check with your municipality, Pinellas County, or the SWFWMD for current water restrictions in your area.

Lawn and Landscape Water Use Rules - Potable, Private Well, and Surface Water Sources Watering with potable (city) water, water from private wells or private connections to surface water sources (lakes, ponds, etc.) is restricted according to property address number as follows:

- Addresses ending in an even number or the letters A through M are permitted irrigate, if necessary, on Tuesday and Saturday only.
- Addresses ending in an odd number, the letters N through Z, and locations with no address are permitted irrigate, if necessary, on Wednesday and Sunday only.

Even Addresses or	Odd Addresses, the
the Letters A through	Letters N through Z, or
M	No Address
Tuesday and	Wednesday and
Saturday ONLY	Sunday ONLY

- Irrigation is allowed from 5 a.m. to 9 a.m. and/or from 7 p.m. to 11 p.m.
- Hand watering of non-lawn landscape is allowed at any time, on any day, if needed. An automatic shutoff device must be installed on your hose and used at all times.
- Hand watering of lawn / turf is allowed ONLY during your designated watering days and times.
- Micro-irrigation (low-flow or drip irrigation) is allowed at any time, on any day, if needed.

Illegal DECEPTION by Post Office – AGAIN!

The Post Office blitzed Jungle Terrace residents with a Postal Form Letter about imaginary hazards to carriers ..."In an effort to reduce the chance of our carriers being injured by some of the hazards that may exist on your property, sometime in the next 60 days you may receive a notice from your local delivery unit asking you to correct the hazards annotated on the notice. Once you have been notified, you will have 30 days to correct the hazard. If the hazard is not corrected, mail delivery may be suspended until such time that the hazard has been corrected." Resident writes: I have a bad back for years. I sweep the sidewalk to the front porch daily. We have no dog. Our cat runs and hides from everyone. Our mailbox is shoulder height on our front wall. Nothing's changed in our front yard in 20 years. So - Is this another cyclical effort to have us place mailboxes at the curb again?

YES, this is a cyclical P.O. effort. Neighbors went through this several years ago:

Post Office offered free mailboxes to non-English speaking people. We waged a major campaign, with a visit to Congressman Bill Young's office where his aide George Cretikos (parents both career postal workers) looked up the Federal Regulations. VOILA! St. Pete's ORDINANCE that mailboxes MUST be on the home/business, no street boxes PREDATED the regulation and was GRANDFATHERED in as valid and superseding the regulation.

Postal workers stole our many yard signs; stored them in the Post Office. Someone told us where they were, and the Postal Inspector from Tampa came over, and on TV returned them to us with "No comment."

The postmistress at that time took a (forced) early retirement.

Our City Officials must take action and stand firm: immediately tell the Postal Inspector (in Tampa) to inform the St. Pete Post Office to cease its bogus attempts for curbside mailboxes.

WRITE, CALL, EMAIL or FAX City Council and Mayor to stand TOUGH in the face of the Post Office, and to tell the Postal Inspector to STOP Postmaster Russ Racine's illegal and deceptive efforts to have street mailboxes . . . again.

Prior to the start of the meeting, there was an Ice Cream Social. Dr. Ed Carlson, JTCA President, called the meeting to order at 7:00 PM. Twenty people attended the meeting.

Community Officer Detty, led off the meeting by summarizing crime in our neighborhood. Vehicles most often broken into or stolen are Chryslers and Dodges. A car alarm or "Club" is a worthwhile investment, as it only takes seconds for the thieves to gain entry and steal a car. Officer Detty reminded us that most of the home robberies are happening during the day time and we should be aware of our neighbors and neighborhoods. Whenever you see something suspicious, please call it in to police non-emergency number is **893-7780**.

Councilman Herb Polson was the guest speaker at this meeting. Mr. Polson addressed many issues of concern to the Jungle Terrace Neighborhood, highlighting a new identification system being implemented on the Pinellas Trail. Every 200 ft on the Trail will be a marker on the ground with a unique positioning code and 911 for emergencies. The GPS coordinates of each marker will be known by the city 911 system, to enable quick location and response to the situation. Each marker will also bear a non-emergency number to report other matters such as trash clean up or graffiti removal.

Larry Ahern, State Representative for District 51, was present at the meeting. He is running unopposed in the November 2 election.

Tom Killian announced a Dumpster weekend coming in December, 12/17 - 12/19. Anyone with

old furniture or other items that will not be accepted by the Recycling Center may discard it in the large dumpsters. There will be three dumpsters located in the parking lot near the Dog Park. Tom also made a request for volunteers for Newsletter folding, the Easter Egg Hunt and Green Thumb.

Dr. Ed Carlson, JTCA President, pointed out the there have been 80 new trees planted in the Walter Fuller Park long the lake area. He thanked all speakers and attendees and adjourned the meeting at 8:30 PM.





Gold and Silver prices are at a all time high. Gold over \$1,100.00 an ounce and Silver approaching \$20.00 an ounce. If you have gold or silver items and need money, now might be the time to sell. Be careful who you sell them to, make sure they are reputable dealers who pay top dollar. Prices vary from dealer to dealer please check before you sell.

Scrap gold prices on rings vary, 10K the least valuable, 14K and above the most valuable. Scrap silver coin prices are 12 times face value. If you

have a silver dime 1964 or earlier it is worth \$1.20, silver quarter is worth \$3.00, silver dollars are worth \$12.00.

Be sure to check the dates on your coins to see if their age value and specific date exceeds scrap prices. You could have coins worth hundreds or thousands of dollars in value. You would not want to sell them at scrap prices and have the dealer make the profit that you deserve. Check with someone who has a current coin book to check values.

I have used the prices for scrap silver coins from David Reynolds Coins on 4009 Central Avenue in St. Petersburg. Reynolds Coins has consistently paid the highest prices for gold and silver in our area.
