Joe Lacki, Architect, President St. Pete Pickleball Association, shows Councilman Gerdes how to get 6 courts in place of 4. Speaking on 7 areas provided 3 weeks in advance, Councilman Gerdes:

- **1. Science Center progress. \$5 Million in Grants. \$8 Million to renovate.** May cost city \$350,000 (of \$748 Million Budget, \$37 million increase) for Education. Tear down to build Pickleball Center. Opposed by neighborhoods and Pickleballers. Not seem interested in what neighborhoods want in their best interest.
- 2. Jungle Lake Management. Continuing major issues . . . Is there a contract with a Lake Management company? Yes. Lost treatment company, not notice for 2 months. (Lake overgrown 7th time.) "Jungle Lake only lake with 2 Baffle Boxes." (We have been asking for 2 more!) Nothing on constant flow of pollutants to Boca Ceiga Bay, or need to "Protect Boca Ceiga Bay" from Red Tide, Algae Blooms, Sea Grass kills.
- 3. January Board letter: WF to be Pickleball-Only-Facility ~ at request of Parks and Rec. Update on WF and city as a whole regarding Pickleball. Details on New Courts and Shared Courts, Citywide and JT. "Building 6 courts at Bartlett Park and at Lake Vista on southside." "City did study, Tennis and Pickleball courts equally used."

Uproar from Pickleball Players! 40-50 players on PB courts, **empty** Tennis. Note: City looked at tennis courts only for one week. Half the times no use. SPPA did 12 day study of 4 locations in city ~

794 Pickleball Players to 46 Tennis players including 6 children.City Summer League 110 Pickleball Teams, c. 330 Players.More PB Leagues than any other sport in the city!

- 4. Albert Whitted Airport talk of "repurposing." Past Referendum: 73% Yes to keep as airport "forever" in ballot language. Council sense on new referendum. Still in talking stages.
- 5. Porter Property on 22nd Ave N why is city opposed to mixed use to include a Crystal Lagoon? Progress report. Nothing specific.
- 6. Coliseum Sound System Upgrade Report/Proposal, 3 options, world-class audio expert. No movement.
- 7. Band Shell Rebuild Williams Park and Sound System No decisions made.



"She created a "hostile work environment" and "culture of bullying" while providing little communication or guidance."

Taylor's accusations are **similar to those made in a letter signed by some of Welch's former campaign staff.** Prior to being appointed by Welch to serve as deputy mayor and chief of policy, Owens was Welch's campaign manager and transition director.

The letter, with signatures removed out of fear of retaliation, was provided to the Tampa Bay Times by a former campaign staffer who was one of the people who signed it. A high-ranking campaign worker who read it at that time confirmed its authenticity. The letter begins with praise for Welch's campaign and his 15-point victory in the August 2021 primary election.

"Since the majority of the team was formed in May of 2021, the campaign's central leadership has been vested in our campaign manager, Stephanie Owens," the letter reads. "Over the course of the past four months **under her leadership**, **the campaign internally has devolved into a toxic work environment that has taken form in instances of aggression, rudeness, deception, deep unprofessionalism and a general negativity to people both inside and outside of the campaign."**

"Each of us have stories and experiences that have compelled us to pen this letter."

Mayor Welch has some explaining to do

St. Petersburg Deputy Mayor Stephanie Owens resigned Friday after she was accused of creating a "culture of bullying." The move likely saved Mayor Ken Welch from having to fire her, but the resignation cannot be the end of this story. The allegations and the fallout raise a lot of questions. Among others: Why did the mayor hire Owens into the No. 2 job in the administration, and why didn't he move sooner to remedy the situation? Did he not know what was going on, or did he not think it was that serious? Either way, there's a lot of explaining to do.

News spread Thursday that city communications director Janelle Irwin Taylor had resigned from her \$127,000-a-year job after only seven months. In a letter to the mayor, Irwin Taylor wrote that she had complained about Owens' behavior, but not enough was done to address the matter. "I have determined that the disclosed hostile work environment, lack of communication or guidance and overall culture of bullying, all related to my direct supervisor, were not adequately addressed, and thus warrant my immediate departure from this administration," Irwin Taylor wrote.

On Friday, Welch suspended Owens, who soon after announced her resignation effective Sept. 9. In an email to city staff, Welch said many of the right things about ensuring a "high standard of civility and professionalism." But this isn't some rogue city employee working in a far-flung office whom the mayor never sees. This is his only deputy mayor, the person he has said he works most closely with to run the city, accused of bullying another high-level administrator, Irwin Taylor. Where was the oversight? Where was the intervention? And why did Welch hire Owens in the first place? She was Welch's campaign manager and transition director before he chose her to serve as deputy mayor and chief of policy after he won the election last year.

But several members of Welch's election team were upset that Owens created a toxic work environment during the campaign — and that they complained to Welch at that time.

This story is still evolving. The details will matter — who knew what and when, and what did they do or not do with that information? But it doesn't look good. It never does when a deputy mayor resigns under a cloud like this. The mayor is only eight months into his term, and he has a chance now for a hard reset, to lead from City Hall, to be present, to show the city and his staff what he stands for. But to begin to get there, Welch must facilitate a full airing of what happened, including his own role. Anything less will raise even more questions.



Giant Snail invasion grows

Giant African land snails — "one of the most damaging snails in the world" — have infiltrated the county's second-largest city, New Port Richey, and its immediate surroundings. State agriculture officials say they have already captured more than 1,000 of the fist-sized invaders since identifying the first intruder on June 23.

"Let me assure you: We will eradicate these snails," Florida Agriculture Commissioner Nikki Fried said.

This is not Florida's first skirmish with the pests. The state thwarted two previous yearslong incursions around Miami-Dade County, first in the late 1960s and early 1970s, then again between 2011 and 2021. The last battle cost \$23 million.

Giant African land snails eat hundreds of types of plants and sometimes even the stucco or plaster off buildings, which provides calcium to harden their shells. They can carry rat lungworm, a parasite known to cause meningitis in people — making the snails a real threat to humans, not just a nuisance. Scientists have not detected rat lungworm in any of the snails caught in Pasco.

The biggest snail was 4.5 inches. Snails were found on 29 properties. But the battle ground is wider: The state set up a "quarantine" area from U.S. 19-Ridge Road intersection, east to Little Road and south to Trouble Creek Road. They warn residents not to move the snails or materials such as plants, soil, compost and yard waste without a compliance agreement from the agriculture department.

There are 30 workers on the state's strike team. Two dogs are part of the effort. The dogs are trained to sniff for snails and to alert their handlers when they catch the scent by sitting down. No one wants the dogs to bite a snail and get sick.

The state is putting out pesticide to kill the snails. The bait is called metaldehyde. It upends the African land snail's mucus production, triggering lethal dehydration. State workers warn homeowners before they apply the pesticide.

A Pasco resident first detected the invasion. They saw large snails in their yard and told U. of FL. Institute of Food and Agricultural Sciences, which alerted the state.

Giant African land snails entrench themselves quickly. One snail can generate more than 2,500 eggs in a year!

The snails look similar to a variety popular in the European pet trade, he said. It's illegal to import or keep giant African land snails as pets here without a permit, according to the state. But authorities have caught people trying to bring the pests into Florida, including some that look like the snails they're now finding in Pasco.

The war will not end anytime soon. The state can only declare victory, in this case "eradication," two years after the last live snail is caught, Fried said. "We will do whatever's necessary."
